

Summary of Results – you must enter how many dogs and bitches have entered and then competed and if none write 0 and total up how many dogs competed.

Each level of IPO 1,2 or 3 should have its own separate scoresheet, even if there is only 1 entrant at that level. This also applies to "FPr" and "UPr" levels 1, 2 & 3.

TEMP TEST – Must also be completed, a simple Y or N

OVERALL SCORES & GRADES – add the points up and match with relevant grade. If DQ, TERM no total is given and grade of M is used

TSB or courage rating, for all dogs that participate in phase c, an evaluation is given, "A" "vh" or "ng" – this must also be entered
